LCCC Information: Questions about the National Online High School were asked at the last meeting. Becky met with Jay Sears and he reported that the National Online High School will not be recognized in Nebraska unless the corporation has met Rule 12 or 18. UNL Online High School is the only recognized online high school that is accredited.

Concern about the Superintendent's plan approved at the LCCC. The Early Childhood plan was passed in August. The plan was vague but indicated an expectation of additional professional development. Do locals need to discuss how extra professional development will be bargained. Districts may need to give up space to staff such as Family Liasons. Some of our districts are already using portables. Who do these people work for? Should we be helping them organize? How would contracts for "teachers" in the LCCC programs be different than other teachers in a district.
