



Nebraska Early Voting Ballot Application

! Applications must be physically signed. You can take a picture or scan your request and email it to your county election official. You can also mail or fax your application to your county election office.

You can start requesting a ballot 120 days before any election. You must submit your application to have a ballot mailed to you by the close of business on the second Friday before the election.
