PARTICIPANT EXPENSES FOR THE EDUCATION IMPERATIVE

Expense Policy

NSEA will reimburse local association participants who attend The Education Imperative for the following expenses:

1. Lodging for **PARTICIPANTS WHO LIVE MORE THAN 60 MILES FROM the Courtyard by Marriott – Lincoln Downtown/Haymarket – 808 R St, Lincoln, NE 68508:** NSEA will reimburse conference participants half of the room cost per night. A paid hotel receipt must be attached to your expense voucher. To be good stewards of NSEA Funds, NSEA members who live within 60 miles of Courtyard by Marriott – Lincoln Downtown/Haymarket will not be reimbursed for hotel costs. Members are responsible to make their own hotel reservations.
2. Mileage for **ALL PARTICIPANTS:** NSEA will reimburse for round-trip mileage from the participant's home address to the conference site (808 R St, Lincoln, NE 68508) and return at the IRS rate. The mileage reimbursement is only to those participants who actually drive to The Education Imperative. If you ride with someone, you are not eligible to receive a mileage reimbursement. Participants are encouraged to share rides if possible.

Reimbursement Procedures:

When you register at The Education Imperative, you will receive an NSEA expense voucher. It is important that you complete the voucher and return it to NSEA by March 8, 2024.

The completed voucher for those who stayed at the hotel must include the actual miles driven round trip from the participant's home address, **and a receipt for your hotel room.** Participants eligible for hotel rooms are responsible for making their own hotel reservations.

Those who did not stay at the hotel must include the actual miles driven round trip from the participant's home address to Courtyard by Marriott Lincoln Downtown/Haymarket.
