NSEA-Retired Upcoming Elections

Open positions on the NSEA-Retired Board of Directors for three-year terms are one board member from the Capitol District, one from the Elkhorn District and one from the Sandhills District. The current board representatives from Elkhorn and Sandhills Districts are term limited. The offices of president and vice president of NSEA-Retired are also three year positions up for election. Candidates elected to these positions will take office on Aug. 15, 2020. Any NSEA-Retired member in good standing is eligible to seek election to these openings. Delegates must live in the NSEA District they wish to represent.



Projected numbers for Delegate Assembly representation by NSEA-Retired members appears to continue at four delegates from Capitol District; five from Metro District; three from Tri-Valley and three from Elkhorn Districts; and one from Panhandle and one from Sandhills Districts. Two more DA delegates will be elected on an at-large basis. The NSEA-Retired delegation to the NEA Representative Assembly will include two from the Metro and Capitol Districts combined; two delegates from the remaining four districts combined with the out-of-state members; and one at large representative. The NSEA-Retired president serves as a delegate to both DA and RA by virtue of office. Final representation numbers for DA and RA will be assigned the middle of January.

Filing for NSEA-Retired elections begins online Monday, January 6, at <u>nsea</u>. org/retired and the filling deadline is February 7. A short 50-word biography must accompany self-nominations for the NSEA-Retired board positions and Representative Assembly delegates. Ballots will be mailed by the end of the third week of February and returned by the March date indicated on the ballot.

Over the years, Nebraska has consistently ranked in the top 10-15 states for quality public education but, amazingly, Nebraska ranks near the bottom of all states in the nation

– 45th – in the percent of state revenue supporting public schools! Every year NSEA/NEA strives to maintain adequate funding for the schools we have helped build.

Last year NSEA staff and teachers actively opposed the erosion of state aid to public education, a bill to allow an income tax deduction or tax credits for parents sending students to private schools, and drastic changes in property tax laws that would have been crippling to public school funding in Nebraska. Recent Nebraska benefits from this NEA fund have helped pass minimum wage and Medicaid initiative petitions.

Bit of History

"Of all the changes in the history of the Association, perhaps the single most important organizational development was the decision to employ a full-time professional Secretary (Executive Director). In fact, some might argue that before the new association's constitution was adopted in 1920, the major work of the Nebraska Association was the annual meeting." In 1938 a woman, Neola Skala, was named as Acting Secretary for a few months in Nebraska. Forty-six years later, Judy Behnke was believed to be only the third woman in the U.S. to hold the chief staff position of an education association when she was named NSEA Executive Director.

Investment Discussions at Fall Conference

Mason Doughty, financial advisor for CIO Wealth Strategies, presented one of the breakout sessions at the retired fall conference in Kearney. There were three topics that seemed most relevant to the conversations. The following are based on topics and suggestions from Mr. Doughty.

1) Qualified Charitable Distributions (QCD's) are the ability to use all or part of your Required Minimum Distribution to give directly to a church or charity and avoid taxation on the distribution. Many clients are now taking a standard deduction and not receiving tax benefits for their gifts to church and charity. QCD's might be a way to maintain the standard deduction and write off a portion of your mandatory IRA distribution as well. A video that explains the QCD is found at https://www. advisorcompass.com/web/advisorcompass/-/video-smart-charitablegiving-from-your-ira* Note: QCD's must be distributed and recorded correctly. Be sure your tax professional and financial professional are on the same page.

2) Federal marginal tax rates were discussed. The current laws are set to sunset in 2025 and this has created a potential window of opportunity. (During this window of opportunity, clients should understand whether this would be in their best interest. This requires some analysis of current and future projected income.) Many clients are converting IRA assets to ROTH IRA accounts to intentionally pay the taxes now at lower tax rates and allow the dollars to grow within a ROTH IRA tax-deferred and then

distributed later in retirement or passed on in the estate free of taxation. These choices are based on age and account value. Some clients find the rising Required Minimum Distribution amounts can cause problems with increased taxation or possible rising Medicare premiums. Also, many married couples are in a lower tax bracket than if they were single. Should a spouse pass away, the surviving spouse may then be in a higher tax bracket as a single tax filer. This can result in increased taxation on the dollars within the IRA account.

3) Sequential Rate of Return Risk was also discussed. It is imperative investors understand the risk within their portfolio and how a market recession would impact their investment value. Clients may not fully understand the holdings within their accounts, are taking more risk than they assume, do not have a distribution plan (order in which to spend their

This plan has a dental option if chosen upon initial enrollment in the supplement plan. Insurance premiums for this supplement remain the same as last year and can be reviewed by going

to ehaplan.org, selecting retiree from the menu and Educators' Medicare Supplement from the options. You may also contact BCBSNE's Member Services Department by calling 877-721-2583 or the number on the back of your member ID card. Jon and Nicole recommended the website medicare.gov for Medicare information, especially for the drug plans. The Educators' Medicare Supplement is available to people who are sliding over from an EHA plan OR are members of NSEA-Retired, annual or lifetime. Many participants are both of these.

Retireds Helping to Host Retirement Presentations to Locals

Organizational Specalists, Mike Wiesen and Kristen Sedlacek have organized and presented information on the Nebraska Retirement System for over 200 Nebraska educators at six sites this fall: Valentine, Palmer, Geneva, Elkhorn, Norfolk, and McCook. Several locals were involved at many of these sites. Retired members Marina Garner, Sharon Bohling, Guy Roggencamp, Jan Greenland, John Heineman, and Dot Snesrud helped to host an event and greet the participants. Medicare Enrollment Reminders

If you collect Social Security at age 65, you are automatically enrolled in Medicare Part A and B. If you don't collect Social Security, you can enroll during one of three enrollment periods:

1) Initial Enrollment Period (IEP): This time extends from 3 months prior to the month you turn 65 (birthday month), your birthday month, up to 3 months after your birthday month (a seven month window). This is when most individuals enroll in Medicare for the first time.

2) General Enrollment Period (GEP) which extends from January 1 through March 31. If you



did not sign up for Part A and/or Part B during the Initial Enrollment Period, you can sign up during General Enrollment. Your coverage won't start until July 1 of that year, and you may have to pay a higher Part A and/or Part B premium for late enrollment.

3) Special Enrollment Period (SEP) allows for Medicare enrollment anytime during the year when certain life events occur. Some examples of such circumstances include leaving a current employer's sponsored health plan, relocation to a new area or your qualification for Medicaid or Extra Help changes.

From October 15 to December 7 is a time for what is called the Annual Election Period (AEP) when all Medicare beneficiaries are able to change their Medicare participation options including the prescription drug coverage for the upcoming calendar year.
